## **ACKNOWLEDGMENT**

This Acknowledgment, including the Privacy Notice at www.ets.org/legal/privacy, contains the terms and conditions between you and Educational Testing Service ("ETS," "we," "us," "our") regarding the ETS test you are now registering for and/or the testing products and services you are now requesting (these are together referred to as "Testing Services"). #### **Personal Information**

## **How We Use Your Personal Information**

We use your Personal Information to:

- complete any registration, purchases or other transactions you request
