

Connecticut Test Takers Overarching Retake Policy 2025-2026



Guidelines for Connecticut Free Praxis Subject Assessment Retake Vouchers

- ✱ For individuals to be eligible for a voucher, they must: Have missed the passing score by no more than 1 **Standard Error of Measurement (SEM)*** for Praxis Subject Assessments or 10 points for the American Sign Language Proficiency Interview. (All CT required Praxis assessments and their passing scores are on the Praxis website at <https://praxis.ets.org/state-requirements/connecticut-tests.html>)
- ✱ The voucher covers the test fee or Praxis Bridge course fee. Previously paid fees are not refundable.
- ✱ If you are eligible to receive a voucher for more than one test, a separate voucher must be submitted for each test.
- ✱ Upon receipt of the voucher, ETS will process and issue a voucher code directly to you via email, which can be used to register online for a free Praxis retake or the Praxis Bridge Program course. (Note: The Praxis Bridge courses are only available for certain Praxis test titles). Praxis Bridge information: [Connecticut Overview](#)

- ✱ The voucher does not cover service fees. You are responsible for paying any change fees or other service fees. Please see the Praxis Bulletin for details or visit us at <https://praxis.ets.org>.
- ✱ In the CT specific Praxis Testing retake voucher policy, each eligible test taker is limited to 2 vouchers per test over the course of the test taker's testing history.
- ✱ To be eligible for a voucher for the Elementary Education: Multiple Subjects test, the eligibility criteria must be met for all four subtests, or separate vouchers may be submitted for any qualifying subtest(s).
- ✱ This voucher program is an addition to and does not replace the regular "fee waiver" program that currently exists for Praxis test takers. Guidelines for the Praxis Free After 3 Program

- ✱ If candidates do not qualify for the CT Free Praxis Subject Assessment Re-test Certificate Program, a CT test taker may be eligible for the Praxis Free After 3 program.
- ✱ **To Qualify:**
Candidates must have taken the same Praxis test three times—with the first of three attempts on or after October 1, 2025—and have reported scores for each attempt after 10/1/2025.
- ✱ Note: There's a 28-day waiting period between testing attempts.
- ✱ **Once eligible:**
 - The test taker will receive automatic notification from ETS that they are eligible and instructions to apply for a voucher.
 - Once verified, the test taker will receive a free retake voucher.
 - Candidates have 6 months to use a voucher and may apply for unlimited retakes within a 5-year window from the date their third attempt's scores were reported.
